Bill C-51 & C-52 Must be Stopped!!

The people's request is simple:

That the Natural Health Products must have their own Legislative Act—Distinct from and not a subset of the drug or food category, and with regulations and enforcements which reflect the historical safety of these health products, which do not cause harm, unlike drugs which carry real and proven serious risks.

The superficial proposed amendment changes to **Bill C-51** do not address any of the critical issues raised by Mr. Buckley's initial Draft Discussion on Bill C-51. (www.nhppa.org)

Bill C-52 sets a precedent where Canadians will lose some of their rights in the name of perceived "safety".

This is happening in our own back yard. Mr. Terry Bell of "Wild Vineyard" located in Selkirk Manitoba, has been unfairly targeted by Health Canada. Health Canada has confiscated several hundreds of thousands of dollars of products from his warehouse claiming they were contaminated. Independent lab tests from a reputable laboratory in Alberta revealed no contamination. This travesty of justice happened even before the implementation of Bill C-51 and C-52. How much worse will it become should Health Canada receive even more powers if these bills are passed?

We have been patronizingly reassured by Health Canada and the Federal Government that they have only good intentions with regard to C-51 and C-52. But their actions for the last 10 years on this issue, have not lined up with their promises.

Come and hear what has already been happening in other provinces. –About other products that have been confiscated from stores, warehouses and have been denied entry at our borders.
